Guidance Notes

- 1. Every eligible BWFCST member has the opportunity to stand for election to the trust board. They must be aged 16 years or over and a member of the trust on the date the nomination form is submitted.
- 2. By submitting a nomination, candidates will be deemed to have accepted the BWFCST Election Policy, the BWFCST Model Rules, and any other policies and rules adopted by the trust board and the membership and agreed to be bound by them.
- 3. Candidates wishing to stand for election to the BWFCST board are required to produce an election address of between four hundred and one thousand (400-1,000) words, either on this form or on a separate sheet of paper. The election address should be typed or word-processed and should be emailed to the with the candidates nomination. Election addresses will be published and circulated to all members along with ballot papers.
- 4. The election address should describe why you feel you should be elected to serve on the BWFCST board
- 5. Any address longer than 1,000 words will be truncated by the directors and the following comment added: "The candidate's election address has exceeded the permitted one thousand words and has therefore been truncated".
- Candidates should also submit a photograph for publication with their statement.
- 7. The election address must not include threats, insults, derogatory, abusive, racist, sexist, or homophobic remarks or references to other candidates. Any comments deemed to fall under the above will be removed and replaced by a comment explaining the removal.
- 8. In agreeing to be nominated, you agree to indemnify the trust for the cost of meeting any liability of the trust that may arise as a result of the content of your election address.
- Completed nomination forms, including election addresses, should be sent to <u>Civica Election</u>

- 10. If a candidate is unable to obtain the original signatures of all the nominators on the nomination form, the candidate may return the form unsigned by some or all of the nominators, but showing instead the e-mail address of the nominator(s) as recorded against that member's details on the trust's membership database. The nomination will be considered valid upon receipt of an e-mail by Electoral Reform Services from that email address confirming the nomination. The e-mail should include that member's name and postal address.

The closing date for receipt of nominations is 5pm on Monday 16 March 2020.

Voting lines will be open from Thursday 26 March 2020 and will close on Thursday 09 April 2020. Election results with be published on Wednesday 15 April 2020
